### **Terms of Reference**

## Short Term Consultant - Implementation of Sustainable Development Goals

- 6. Analyze and utilize data and observations from field visits, HMIS, Quarterly Progress Reports to address bottlenecks in implementation and suggest way forward with evidence based research.
- 7. Appraise proposals and programmes from states to facilitate decision making by the Ministry of Health
- 8. Liaise with implementing partners at the Centre or State level
- 9. Coordinating and collaborating with other divisions of ministry
- 10.Shall be capable to undertake multitasking with a wide horizon and overview on public health perspective and approach for the assigned tasks.
